RESOLUTION OF ACCEPTANCE ACCEPTING QUITCLAIM DEED FROM CONTRA COSTA COUNTY SANITARY DISTRICT FOR SEWER LINE EASEMENT OVER 2477 ARNOLD INDUSTRIAL WAY (APN 159-050-057)

WHEREAS, the County of Contra Costa and the Cities of Clayton, Concord, the Town of Danville, Lafayette, Martinez, the Town of Moraga, Orinda, Pleasant Hill, San Ramon and Walnut Creek (hereinafter "Member Jurisdictions") have formed the Central Contra Costa Transit Authority ("CCCTA"), a joint exercise of powers agency created under California Government Code Section 6500 et seq., for the joint exercise of certain powers to provide coordinated and integrated public transportation services within the area of its Member Jurisdictions; and

WHEREAS, during the original construction of CCCTA's administration and maintenance facilities on Arnold Industrial Way, a dedicated sewer line was installed, which serves CCCTA's administration building, fuel island and maintenance building; and

WHEREAS, once CCCTA occupied the facility, the sewer line at 2477 Arnold Industrial Way should have become CCCTA's property and responsibility, however, during the upgrade to the waste water separator at the fuel island in 2009, it was discovered that the Contra Costa County Sanitary District ("CCCSD") retained ownership and an easement to the sewer line; and

WHEREAS, it is CCCSD's policy to relinquish ownership and future maintenance responsibilities to the owners of the property on which sewer facilities exist; and

WHEREAS, on April 1, 2010, following public notice and a public hearing, the CCCSD Board of Directors adopted Resolution No. 2010-017, "Resolution of the Contra Costa County Sanitary District Ordering Relinquishment of Sewer Facilities to Central Contra Costa Transit Authority" and Resolution No. 2010-018, "A Resolution Authorizing Execution of a Quitclaim Deed to Central Contra Costa Transit Authority, District Job No. 3615 - Parcel 1, APN 159-050-057" in order to relinquish the sewer line and quitclaim the associated easement, attached as Exhibit A; and

WHEREAS, in order to finalize this transaction, CCCTA's Board of Directors must accept the quitclaim deed by resolution; and

WHEREAS, staff recommends, and the Operations & Scheduling Committee concurs, that the Board of Directors accept the Quitclaim Deed of the easement to the sewer line from CCCSD.

NOW, THEREFORE, BE IT RESOLVED by the Central Contra Costa Transit Authority Board of Directors, that the Central Contra Costa Transit Authority hereby consents to the acceptance of the Quitclaim Deed - Easement from the Contra Costa County Sanitary District, consisting of all rights, title, and interest that CCCSD may have in the particular easement situated in the City of Concord (unincorporated), County of Contra Costa, described in the Grant of Easement recorded August 9, 1982, as document number 82-88799 of Official Records of the County of Contra Costa, dated April 1, 2010, District Job No. 3616 - Parcel 1, Concord (APN 159-050-057); and

BE IT FURTHER RESOLVED that the Chair and the Secretary are authorized to execute a Certificate of Acceptance pertaining to the Quitclaim Deed for presentation to the Recorder of Contra Costa County.


