## CALL TO ORDER/ROLL CALL/CONFIRM QUORUM

Alternate Member Andersen represented the Town of Danville. Director Hoffmeister arrived after the meeting convened. Directors Schroder and Worth were absent. Chair Hudson introduced and welcomed Alternate Member Andersen to the meeting.

#### REPORT OF CHAIR

Chair Hudson referenced a handout he distributed at the meeting today regarding a bike sharing program instituted by the Metropolitan Transportation Commission (MTC) on the peninsula in San Francisco. He felt this would be a worthwhile program for implementation in the CCCTA service area. For the Winter Spare the Air Day program, Chair Hudson advised there may be some funds available for advertising on CCCTA buses. He asked staff to remove an old bus stop near the Dublin City Hall that was replaced by a new bus stop.

#### REPORT OF GENERAL MANAGER

## Recognition of Employees with 20 Years of Service

Mr. Ramacier recognized former Transit Operator Curtis Perrilliat for his twenty-one years of service.

#### Minor Changes to Route 98X

Mr. Ramacier reported that the O&S Committee approved a minor change to Route 98X. This route is funded with RM2 funds from MTC and provides express service between Martinez and Walnut Creek. The service has struggled to meet the MTC performance standards relative to RM2 funds. The corrective action approved by the O&S Committee is a reduction in service that will still accommodate the riders with minimum impact. Staff anticipates the same number of riders will use the service after a reduction in service during times when ridership is low. The reduction affects the headways and represents a cut of about 10-15% of the service. Due to the RM2 funding source, CCCTA staff is required to go to MTC for approval of this corrective action and a commitment to continue to fund the service, which will have a financial impact on CCCTA. The service was originally envisioned as a commuter route, but it is being utilized by transit-dependent riders to access the county hospital. It was very important to the O&S Committee to make sure that that presence of service remains.

(Director Hoffmeister arrived.)

## Potential Impact of the Election on Transit

Mr. Ramacier advised a report will be given to the MP&L Committee next month regarding how the election may impact transit, in particular Propositions 22 and 26. Proposition 22 protects local development funds and transportation funds greater than they are protected today. Proposition 26 redefines many fees as taxes and, thus, requires a two-thirds vote to enact them in the future. Because this measure takes effect on January 1, 2010, it is not clear how it will impact the gas tax swap passed by the California Legislature in March. The worst case scenario for transit is if the gas tax swap is determined to be invalid. In that case, the increase in sales tax on diesel is illegal and must stop, which would reduce CCCTA's funding. A best case scenario is if Proposition 26 not only invalidates the gas tax swap but the legislation that was passed and signed into law that implements the gas tax swap. In that case, the repeal of the sales tax on gas is negated and returns, which would be a boon for transit because Proposition 22 now protects those funds.

On the federal side, the new Congress will be less inclined to provide a large increase in a transportation reauthorization bill. Discussions are now focused on a two-year bill that would get Congress back on track for reauthorization every six years. Mr. Ramacier also advised that, if there were no transit earmarks, California would receive more federal funds because of the formula share.

#### ADVISORY COMMITTEE REPORTS

Citizens Advisory Committee: There was no report.

Accessible Services Committee: There was no report.

#### **BOARD COMMUNICATION**

Director Simmons reported on a meeting he attended regarding the Walnut Creek BART transit village where a resident advised the current approach is not suitable for buses to make a right turn. He thanked Mr. Ramacier, Bill Churchill, Director of Transportation, and three Transit Operators for attending a recent City Council meeting when they were given a proclamation commemorating the free downtown shuttle. Walnut Creek City staff is looking at ways for businesses to help subsidize the shuttle in downtown Walnut Creek so it can continue to be provided free. Director Uilkema stated that, when there is a mega residential development, one component to be considered is transit passes for the residents as a condition of approval. In essence, this turns into a developer subsidy of transit. Developers seem to be more willing to accept transit passes rather than an outright contribution to transit service.

Director Hoffmeister advised the Concord City Council will reorganize on December 7, 2010 with appointments to various agencies in January 2011. She may or may not be returning to the CCCTA Board of Directors depending on that reorganization.

**SUBJECT:** Express Bus Fares

#### **SUMMARY OF ISSUES:**

The current fare structure identifies a base fare of \$2.00 and an express bus fare of \$2.25 and was adopted in March of 2009. Currently the monthly pass, the 12 ride punch and the senior 20 ride punch are all accepted as payment methods on an express bus even though they are priced for base fare payment.

The result of this practice is that most of the fares paid on express buses are discounted base fares resulting in an average fare per passenger of \$1.21. Because of the need to meet a higher farebox ratio on the 98X, and because the Express Bus fare of \$2.25 is not being implemented to the full extent possible, staff recommended the following change in collection method to the Committee.

Require passengers paying with monthly passes and 12 ride punch passes to add \$0.25 to the farebox when riding express bus routes

The Committee supported the recommendation and staff conducted a public hearing on December 1<sup>st</sup> at which no public showed up. Notice was also posted on the website and there were two comments; "sounds like a good idea" and "you should lower all fares to \$1.25".

### **RECOMMENDATIONS:**

Approve the A&F Committee recommendation to require passengers paying with monthly passes and 12 ride punch passes to add \$0.25 to the farebox when riding express bus routes.

#### FINANCIAL IMPLICATIONS:

The impact will be to increase the average fare to \$1.28/passenger which is calculated to increase the express bus fare revenues by approximately \$24,000 a year.

# <u>AUTHORIZING COLLECTION OF ADDITIONAL \$0.25 FOR PASSENGERS USING MONTHLY PASS,</u> 12 PUNCH PASS, AND COMMUTER PASS FARE MEDIA WHEN RIDING EXPRESS BUSES

WHEREAS, the County of Contra Costa and the Cities of Clayton, Concord, the Town of Danville, Lafayette, Martinez, the Town of Moraga, Orinda, Pleasant Hill, San Ramon and Walnut Creek (hereinafter "Member Jurisdictions") have formed the Central Contra Costa Transit Authority ("CCCTA"), a joint exercise of powers agency created under California Government Code Section 6500 et seq., for the joint exercise of certain powers to provide coordinated and integrated public transportation services within the area of its Member Jurisdictions; and

WHEREAS, in March 2009 CCCTA adopted a fare structure whereby the base cash fare is \$2.00 and the Express Bus cash fare is \$2.25; and

WHEREAS, CCCTA is currently accepting monthly passes, 12 ride punch passes, and commuter cards which are priced based on the base cash fare, for travel on the Express Buses; and

WHEREAS, because under the current practice, the Express Bus Route cash fare of \$2.25 has not been fully implemented, staff recommends changing the fare collection procedures to require passengers to add \$0.25 to the farebox when using the monthly pass, the 12 ride punch, or the commuter card to ride Express Bus Routes; and

WHEREAS, CCCTA held a public hearing on December 1, 2010 to receive public comment on staff's proposal; and

WHEREAS, CCCTA is facing declines in operating revenues and wishes to maximize the fare revenue collected within the adopted fare structure to meet operating expenses,

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Central Contra Costa Transit Authority, after taking into account all of the public comments received to date, the staff recommendation, and the financial condition of the Authority, the Board of Directors hereby approves the collection of an additional \$0.25 from riders who board Express Buses and pay with a monthly pass, a 12 ride punch pass, or a commuter card effective January 1, 2011.
