Subject: Status on Service Changes to Route #5 and #7

Background:

In August changes to routes #5 and #7 were made to implement the recommendations of the Adaptive Service Plan and provide more direct service from the Creekside neighborhood and the Shadelands business park to BART. We now have enough ridership history to evaluate the impact of the changes.

Summary:

The new Route #5 is very successful in large part due to an increase in the frequency of service the City subsidy of the fares resulting in free rides. There was some concern that residents of Creekside apartment complexes wouldn't change their behavior despite the free fare but the ridership by stop report shows that 90 passengers a day are boarding at the Creekside stops.

The new Route #7 now operates from Shadelands to only one BART station as opposed to the past when two stations were served. The route has less service hours due to the shorter route distance. As a result of the reduction in service hours there are less riders. Productivity as measured in terms of passengers per hour is up. County Connection is working with the new Shadelands PBID representatives and staff to come to an agreement regarding free fares for the route.
