<u>Update the Board on County Connection staff interactions regarding Contra Costa Transit Authority's Transportation Expenditure Plan (TEP) Development</u>

It was reported that this process is continuing for now. Staff remains fully engaged in the process. We continue to make statements that the bus transit priority should be working to get key bus routes that serve BART on fifteen minute headways.

### **Update on Federal Transportation Reauthorization**

A five year federal transportation reauthorization has been enacted. This act known as FAST will provide an 18% increase over the five year period in total funding. Staff is confident that FAST will provide the funding we're anticipating from the federal program for all of our vehicle replacement needs over the five year period.

One policy change is a requirement for the Secretary of Transportation to issue a proposed rule making related to safety to increase transit operator safety with respect to passenger behavior.

### **Update on I-680 Transit Investment Study**

The study is complete and has been presented to the Contra Costa Transit Authority's Board. Further meetings will be held and County Connection will be involved in these meetings with the purpose of representing bus service accommodations.

#### **Administration & Finance Committee**

#### FY2015 Draft Audit

Director Simmons informed the Board that County Connection has another clean audit. The committee and the auditors work well together when it comes to understanding the changes in laws that pertain to County Connection's financials and the clean audits prove that. ## **Operating & Scheduling Committee**

### Passenger Suspension/Exclusion Policy

Director Andersen introduced the item and Director of Transportation, Bill Churchill, explained that passengers can behave in a way that disrupts service, for example by using vulgar and/or discriminatory language towards other passengers and/or the driver. Although County Connection calls the police in response to this type of passenger behavior, because the passengers are not being violent towards anyone, all the police can do is remove them from the bus temporarily. This approach often does not resolve this type of situation. For example, we have had a disruptive passenger that caused five different service delays in one day. He was removed from one bus and just caught another one, continuing his disruptive behavior on the next bus. In order to provide County Connection with a tool for dealing with this type of disruptive behavior and provide notice to passengers regarding the types of behavior County Connection considers disruptive, staff and legal counsel have developed a policy defining disruptive behavior and a process that County Connection will follow in order to suspend passengers that demonstrate such behavior. After discussion, the Board asked that the policy go back to the committee for further review to make some minor changes in the language of the policy and its attached passenger code of conduct and to bring it back to the Board under the Consent Calendar.

MOTION: Director Andersen moved approval to send the Passenger Suspension/Exclusion Policy back to the O & S Committee for such changes and to bring the final policy to the Board under the Consent Calendar. Director Simmons seconded the motion and it received the following vote of approval:
