Item 4.c. Approval of Agreement with Waysine for Installation and Lease of Solar Message Signs at Select bus Stops, Resolution 2016-016. Board members desired more information from staff regarding this item. Director of Planning, Anne Muzzini, explained that the bus message signs will be installed at 23 bus stops and the cost will be \$22,000 for the first year and \$38,000 for each subsequent year. The bus message signs will be solar powered and reflect bus information in real time. Waysine will repair and maintain the signs either remotely or at the sign location as needed, which costs are included in the annual costs. This is a pilot program that was funded by grant money. In two years County Connection can review the pilot program and if it has been successful, County Connection can apply for grants that will continue to fund it.

Board Chair Robert Storer thanked the employees for their dedicated service over the last 30 years.

Board Planning Discussion

General Manager, Rick Ramacier, explained that the purpose of this planning discussion is to let the Board know what projects County Connection has in mind for the years to come and hopefully after the discussion the Board will direct staff on setting priorities for the future projects.

Staff provided a power point presentation first discussing a brief history of service hours and how they have declined from 2008-present. Staff then presented a historical snapshot of County Connection's operating trends and a short analysis of the financial reserves. Staff explained that the future operating cost and reserves projection based on 2016 dollars indicates that County Connection can maintain its present level of service, meet its capital needs and maintain a reserve of 10% over a 10 year period. Staff indicated that these projections do not include the following capital projects:

Replacement of underground fuel tanks at \$5 million

Construction of County Connection base parking lot expansion at \$1.8 million

Final Costs of Electric Buses

Bus Replacements-Zero Emission

Staff discussed new funding opportunities and suggested that local generated revenue sources might be available. Staff has considered service expansion ideas from staff and from the communities that County Connection serves. Service expansions will include:

Lamorinda Service Plan

Improve Rapid Bus Service on the I680 Corridor

Implement a circulator in Downtown Concord and/or in Bishop Ranch

Serving the Navel Weapon Station Redevelopment

The estimated cost of all of the above projects could exceed \$10 million a year in operating expenses and \$18 million in upfront capitol cost.

Director Schroder leaves.

Given the cost issues, and after a lengthy discussion, the general consensus of the Board is for staff to work with the appropriate committees to determine what County Connection needs to do vs. what County Connection would like to do.

Director Manning leaves.

SUMMARY OF ISSUES: This item would have ordinarily come to Board in the fall for approval however due to the cancellation of the 2015 November Board Meeting and the retirement of the Director of Finance it was overlooked until now.

County Connection contract under the Public Employee's Medical and Hospital Care Act (PEMHCA) for Administrative employee benefits.

The current MOUs with the ATU and Teamsters increase the Cafeteria Plan annually using a formula that averages the increases in the two (2) most popular health plans by coverage level and splitting that amount and adding it to the Cafeteria Plan.

In recent history the Board has provided the same increases to the Administrative employees cafeteria plan in the interest of equality.

For 2016 the two most popular health plans are Kaiser and Anthem HMO Select. The average increase for PERS HMO plans was 7.21% for 2016.

Attached are the 2016 monthly medical premiums for each employee group, ATU, Teamsters and Administration. The Administrative employee group is shown with the requested increase in the Cafeteria Plan.

FINANCIAL IMPLICATIONS:

The cost to increase the contributions to the Administrative employee Cafeteria Plan using the above mentioned formula is \$15,100. This amount is accounted for in the budget.

COMMITTEE RECOMMENDATIONS:

The A&F Committee recommends the Board of Directors adopt Resolution 2016-012 which increases the Authority's monthly contribution to the Administrative employees' Cafeteria Plan as follows:

APPROVING AND ESTABLISHING THE 2016 CONTRIBUTION RATE FOR THE CAFETERIA PLAN FOR THE ACTIVE ADMINISTRATIVE EMPLOYEES OF THE CENTRAL CONTRA COSTA TRANSIT AUTHORITY

WHEREAS, the County of Contra Costa and the Cities of Clayton, Concord, the Town of Danville, Lafayette, Martinez, the Town of Moraga, Orinda, Pleasant Hill, San Ramon and Walnut Creek (hereinafter "Member Jurisdictions") have formed the Central Contra .Costa Transit Authority ("CCCTA"), a joint exercise of powers agency created under California Government Code Section 6500 *et seq.*, for the joint exercise of certain powers to provide coordinated and integrated public transportation services within the area of its Member Jurisdictions; and

WHEREAS, the CCCTA provides health insurance benefits to its active employees and eligible retirees under the Public Employees' Medical and Hospital Care Act("PERS Health"); and

WHEREAS, the CCCTA funds such PERS Health premiums at rates established under Board resolutions submitted from time to time to the PERS Health administrator, and covered participants are required to fund the balance of such PERS Health premiums; and

WHEREAS, pursuant to Resolution No. 2007-016 adopted December 21, 2006, the Board established a cafeteria plan within the meaning of section 125 of the Internal Revenue Code to provide active, non-represented administrative employees with additional funding for their PERS Health premiums, or with certain other benefits in lieu of additional funding for PERS Health premiums ("the Plan"); and

WHEREAS, Resolution 2007-016 provides that the Board review and establish the CCCTA contribution rate to the Plan on an annual basis; and

WHEREAS, the CCCTA contribution rate for non-represented employees was last modified in 2011; and

WHEREAS, to bring the non-represented employees contribution rate in line with the contribution rates afforded to represented employees with cafeteria plans, the A&F Committee recommends adjustments to the contribution rates for non-represented employees; and

WHEREAS, the Board has determined it to be in CCCTA's best interests to increase its contribution rate for eligible non-represented administrative employees under the Plan.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the CCCTA as follows:

Section 1. For calendar year 2016, subject to the terms and conditions of the Plan, the CCCTA will contribute the following monthly amounts to the Plan for each non-represented administrative employee who participates in PERS Health:

Employee only \$400.24 Employee + 1 dependents \$620.48 Employee + 2 dependents \$830.62

Section 2. For each subsequent calendar year, the Board shall establish the CCCTA's contribution to the Plan, if any, before January 1 of such year. If the Board does not establish the CCCTA's contribution to the Plan for any calendar year, the rates in effect on December 31 of the preceding year will apply.

Section 3. The General Manager is hereby authorized and directed, for and behalf of CCCTA, to take such further action and execute such documents as he may deem necessary or appropriate to carry out the provisions of this resolution.

SUBJECT: Short Range Transit Plan (2016-2025) – Final

Background:

The Short Range Transit Plan (SRTP) is CCCTA's operations and financial planning document. It is required by MTC to be updated annually to comply with funding requirements. It is used to support the allocation of federal funds for bus replacement, and it documents the impact of different budget scenarios. Each chapter has been reviewed by the MP&L Committee and a legal notice was published more than 30 days in advance of the Public Hearing.

The plan focuses on service evaluation, future planning efforts, and projecting operating and capital cost and revenues. Service has been measured against performance standards, which changed to reflect 100% data collection. Service is evaluated at the route and system-level. Anticipated changes in demand are documented and major development plans that will require service adjustments are identified.

A detailed capital program is included that identifies our current revenue and non-revenue fleet replacements as well as other capital projects. The capital plan is a key component of the document as it serves to qualify CCCTA for participation in the regional Transportation Capital Improvement Program and thus federal funding.

The final chapter provides a list of projects County Connection could complete if additional sources of funding became available.

County Connection has received four comments addressing the SRTP. Three of the four comments requested additional service in the San Ramon/Dublin area. County Connection is currently not in a position to expand service; however, as funding becomes available, the requests may be reconsidered. One comment requested shuttle service to County Connection's public meetings. This service is already available. All of the comments have been addressed in the attached document.

Recommendation:

The Marketing, Planning & Legislative Committee has reviewed the plan and recommends the Board approve the FY16-25 Short Range Transit Plan – Resolution 2016-018.

Re: the above, I would ask the Planners be aware of the following 2 service changes LAVTA (Wheels) agency has proposed implementing next January 2017:

- 1. Their "Rapid" route on that part of Dublin Blvd. which overlaps with the 36 will be terminating on the Dublin side of the W. Dublin Bart station instead of at the Stoneridge Mall. It will continue running every 15 minutes weekday daytime, so there will be improved connectivity opportunity at W. Dublin Bart and a small time & fuel mileage savings if the 36 were to terminate there.
- 2. The North Dublin half of their route 3 will be eliminated, so this may increase ridership on both the 35 & the 36. Since the route 3 runs on Saturdays, there would be no Saturday service at all in North Dublin. Whenever funding improves, this could be an opportunity to extend the route 321 southward. Please reconsider. Thanks.

Dear Sirs,

We, the Senior Citizens and residents of Windmere/East Branch area, while thanking you for extending the 'free-travel' facility from 10 am to 2 pm in Contra Costa area for all the senior citizens, would like to bring the following to your kind notice and kind consideration.

At present, Route No. 35 is being operated by CCCTA from Dublin/Pleasanton Bart to SanRamon Transit Centre with 6 trips from 11 to 5 pm from SRTC to Bart and 5 trips from 10.45 to 4 pm from Bart to SRTC, for the convenience of residents living in Windmere/East Branch area. It is only a diversion/extension of the existing route No. 35 in the above timings.

We all would like to bring to your notice that the above services are very meagre and not able to cater to the needs of majority of the people in this area. Excepting the above duration(11 am to 4 pm), we are required to go to Bollinger Canyon/East Branch or Bollinger Canyon/Windmere to alight the bus by walking for 30 mts and return uphill road for 30 mts. Especially for senior citizens, this is causing lot of strain.

For those seniors/residents who would like to go to shopping, Doctor/Labs appointments, to attend any meetings, those who want to go out by Bart and return for any work at far off distances from our area, for office goers, college and school students, and those who would like to go regularly to Livermore or other religious places, are facing lot of inconvenience in the light of limited hours/trips of operation of Route No. 35.

In view of the above, We all would request you to kindly consider the possibility of operating a separate route bus independently on a regular basis from 6 to 9 pm. Or alternatively to atleast increase the number of trips of existing Route No. 35 from 9 am to 6 pm to East Branch/Windmere, as a temporary measure, where 300-400 house are located and sizable population is living in this area, for which we all shall be grateful to you.

At the same, we would like to very much appreciate CCCTA's 'service motto' rather than 'Profit motto' in operating the bus services to all the people in general.

Hello Suryanayana alapati,

I was forwarded your comment by Lisa Bobadilla and have gave her this response.

You are welcome to attend the meeting this evening, but you can be assured that I have heard your request. Adding all day service on the East Branch - Windemere loop all day long would take service away from other passengers.

I understand that some residents would like to see the route #35 travel on the E.Branch/ Windemere section all day long. If we were to do this there would be two major impacts:

- 1) The stops on Bollinger between E. Branch and Windemere would not be served. The stops eliminated would include those used by passengers to access DVC and the Library. Based on ridership data there are 38 boardings (ons) and alightings (offs) at these stops on an average weekday.
- 2) Passengers using the Route #35 to travel to and from Bishop Ranch would have a longer and less direct trip because of the new routing which takes 8 minutes longer. There are 33 passengers (on an average weekday) that get off at Dublin BART in the pm peak period. We can assume these are work trips originating at the Transit Center.

In reviewing the data there are a total of 26 boardings and 45 alightings (offs) at stops on the E.Branch/ Windemere loop per average weekday. The loop is being utilized.

I would not recommend making the change as it would negatively impact current commute riders and DVC students.
