Public Hearing: CCCTA FY2017 Operating and Capital Budget

At 9:03 a.m. Vice Chair Hoffmeister opened the public hearing regarding the CCCTA FY2017 Operating and Capital Budget. Erick Cheung, Director of Finance, stated that the public hearing is being held for the purpose of discussing and receiving public input on the budget. He advised the public hearing was properly noticed in the East Bay Times. The proposed FY 2017 Operating and Capital Budget is \$57,102,671. The operating budget is \$37,092,671, which is funded 80% with local funds, 14% from the farebox and special fare revenues, 4% federal funds, and 2% with other revenue. The operating budget will support approximately 224,324 revenue hours of fixed-route service and 74,394 revenue hours of County Connection LINK dial-a-ride services. Vice Chair Hoffmeister asked if there were any comments from the public regarding the FY2017 Operating and Capital Budget. No comments were received and the public hearing closed at 9:06 a.m.

FY2017 Proposed Final Budget, FY2016 Estimated Actual and Resolution No. 2016-026

Director of Finance Erick Cheung reported that the A& F Committee recommends approval of the final budget for Fiscal Year 2017. The Board reviewed the draft budget in May.
