- 1. Approval of Agenda- Approved.
- 2. <u>Public Communication-</u> Ralph Hoffman noted to vote no on the repeal of Senate Bill 1 (SB1) in the November 2018 Election.
- 3. Approval of Minutes of May 9, 2018- Approved.
- 4. Closed Session:
 - a. <u>Conference with Labor Negotiator-Pat Glenn (pursuant to Government Code Section 54957.6) Employee</u>
 <u>Organizations: Amalgamated Transit Union, Local 1605; Machinists Automotive Trades District Lodge No. 1173;</u>

- 5. Open Session: Report of Action taken in Closed Session Direction was provided to staff.
- 6. <u>CCCTA Investment Policy-Quarterly Reporting Requirement CFO Cheung reported that the portfolio as of March 31, 2018 complies with County Connection's Investment Policy. Approved for the Board consent calendar.</u>
- 7. <u>Adjustment to Non-Represented Administrative Employees Compensation General Manager Ramacier & Director of Human Resources Rettig requested a 3% increase in the pay scale for administrative employees and a merit pool of \$5,000 which were included in the Draft FY 2019 Budget. Approved by the Committee for the Board consent calendar.</u>
- 8. Adoption of Gann Appropriations Spending Limitation for FY 2018-2019 CFO Cheung reported that the spending limit for FY 2019 is \$74,884,205. The budgeted amount for operating and capital that is paid for by nonfederal monies is \$40,235,096 or \$34,649,109 under the Gann limitation. Approved for Board consent.
- 9. Fiscal Year 2019 Draft Budget and Ten Year Forecast CFO Cheung reported that the FY 2019 Budget has been updated and proposes \$39.5 million in operational expenses for fixed route and paratransit with revenues to offset these costs. County Connection's main revenue source is TDA 4.0 funds from MTC; the budget proposes using \$18.5 million which is \$0.2 million more than MTC estimates we will receive next fiscal year of \$18.3 million. This includes the following changes:
 - a. STA Population revenue MTC allocated \$1.0 million to County Connection which represents the FY 2018 SB1 funds and will receive \$3.3 million in SB1 funds in FY 2019 with \$2.1 million being one time in nature.
 - b. TDA Revenue needed The net impact is an increase of TDA reserves of \$1.0 million in FY 2019 from \$8.9 million to \$9.9 million.

The A&F Committee approved and recommended the FY 2019 Budget be put on Board agenda for approval following a public hearing.

SUBJECT: PUBLIC AGENCY RETIREMENT SERVICES (PARS) OPEB Trust

SUMMARY:

Randall Yurchak – Vice President of Highmark Capital Management and Rachael Sanders – PARS Manager, will join us to discuss the investment performance of the trust and share some insights about the future of the markets and trends including their Section 115 Pension Trust.

The A&F Committee selected the Moderately Conservative Index PLUS investment option. The allocation for this option is 20-40% equity, 50-80% fixed income and 0-20% cash.

The balance in the trust as of April 31, 2018 was \$3,134,954.

The annual investment rate of return as of April 2018 was 3.16% but has averaged 3.80% over the last 5 years. These figures are net of all investment management expenses.

SUBJECT: Lifeline Transportation Program Cycle 5 Grant Funding

Background:

On February 6, 2018, the Metropolitan Transportation Commission (MTC) released guidelines for the Cycle 5 Lifeline Transportation Program (LTP). The purpose of the LTP is to fund projects that result in improved mobility for low-income residents of Contra Costa. Approximately \$3.1 million is expected to be available to Contra Costa through MTC from two funding sources over a two-year funding cycle (FY 2017 and FY 2018). The funding sources available are State Transit Assistance and Federal Transit Administration Section 5307 (formula) funding. To be eligible to receive these funds the entity must be a recognized public transit operator.

On February 21, 2018 the Contra Costa Transportation Authority (CCTA) authorized the release of a Call for Projects for the Contra Costa LTP program. Applications for project funding were due on April 6, 2018. County Connection submitted an application for continued funding for services funded by previous LTP cycles. The routes supported by this funding source all serve the Monument Corridor, which includes Route 11, 14, 16, 18, 19, 311, 314, and 316. These routes provide basic transportation services to County Connection riders; 35 percent of whom are low income. All lines serve and/or are predominantly located in Communities of Concern. Public Transit is a primary means of transportation for both the adult and youth populations within the Communities of Concern. All lines presently provide service to employment, services, retail, schools, health care and coordination to BART stations. Funding this project would preserve existing headways and service span.

Financial Implications:

CCTA estimates awarding County Connection \$766,723 to preserve operations in Central County Communities of Concern. The required local match would be funded with TDA funds and farebox revenues.

Action Requested:

Staff recommends that the Committee approve use of the Lifeline funds to continue to fund routes serving Communities of Concern in Central Contra Costa County. A resolution is required by MTC and will be included in the Board packet if approved by the Committee.
