- 3. Approval of Minutes of September 12, 2018- Approved.
- 4. Income Statements for the Fiscal Year Ended June 30, 2018 CFO Cheung reported that the actual expenses of \$35,486,143 are -6.9% (\$2,626,115) under budget for the fiscal year. Expenses are under budget due to vacancies and associated benefits, service contracts, legal services, repair costs, and diesel fuel costs. Finally, the contingency is not needed this fiscal year. Mr. Cheung also noted that fare revenues of \$4,857,447 are -1.0% below budget (\$47,182) with a fare box ratio of 13.7%. Director Tatzin commented on the rising costs of Paratransit services and asked if there are more efficient methods of providing the service. General Manager Ramacier responded by noting the technology improvements for dispatching and scheduling that are coming and there will be a request for proposal in the coming year for these services. County Connection can review what vendors can provide and offer during this process. The committee accepted the report and forwarded to the Board.
- 5. Review of Vendor Bills, September 2018 Reviewed.
- 6. <u>Legal Services Statement</u>, August 2018 General and July 2018 Labor- Approved.

SUBJECT: INSTALLATION OF CHARGING INFRASTRUCTURE AT WALNUT CREEK

BART

BACKGROUND: County Connection received a Federal Low/No Grant in 2017 to purchase

four (4) electric buses and charging infrastructure to support them.

County Connection has taken delivery of four 29-foot Gillig electric buses and plans to deploy them on the Route 5 in Walnut Creek. Operation of this service will require a second WAVE inductive charging system to be

installed at the new transit garage at Walnut Creek BART.

SUMMARY OF ISSUES: County Connection issued an Invitation for Bid on October 10, 2018, for the

installation of WAVE charging infrastructure at Walnut Creek BART and the relocation of existing WAVE from the current location into the new transit garage. The Bid opening is scheduled for November 9, 2018. Staff will not be able to complete Bid evaluation until after the November Board Meeting. In order to meet BART's construction schedule, County Connection needs to award Contract before the December Board Meeting. We have received an Engineering estimate of between \$225,000 and \$300,000 to complete this work. The staff requests that the A&F Committee recommend to the Board to pass a Resolution authorizing the General Manager to award a

responsible bidder at the November Board Meeting.
